CPM Advanced Training on Conflict Awareness and Communication

The conflict management system (CPM) is an integral part of the GlobE Trans-SEC project. Therefore, on Sept. 9th and 10th 2016 the advanced CPM training on *Conflict Awareness and Communication* took place on the premises of the Sokoine University of Agriculture (SUA) in Morogoro, Tanzania; prior to the Trans-SEC Annual Meeting. The training was facilitated by the Trans-SEC CPM team including the Senior Facilitator, Dirk Sprenger, and PhD student Katharina Löhr. Twenty participants from north and south were able to take advantage of the training.

Course of the CPM Advanced Training

The advanced training is a continuation of the CPM conflict awareness training that took place in the last year. The advanced training provided the participants with short practical exercises focusing conflict and dispute, and gave first insights into the work of a conflict mediator. Additionally, Dirk Sprenger introduced us to some relevant techniques that can be used to approach conflict situations.



The group exercises on transformative listening using "from-the-field" cases, which were provided by the participants made the training very relevant for everybody.

The first day focused more on some repetition from the awareness workshop, because some participants joined the CPM workshops for the first time. The second day included learning about advanced skills in conflict awareness and communication. Summarized, the emphasis of the training was on following issues:

- Definition of conflict and dispute
- Key patterns of human perception, attitude and behavior in conflict
- Conflict dynamics

- Methods for working with conflict
- The third side: the role as conflict facilitator.


